## Minutes for December 12, 2006

President Cheetham called the meeting to order at 6:59 PM

**MINUTES:** Minutes were approved for the Nov. 14 meeting

**SHERWOOD ICE ARENA:** Bob Knoerl presented to the board the problem with the coaches not getting off the ice in a timely manner, wasting time in the middle of the ice and then going over at the end when they are suppose to be off the ice. This happens mainly on the weekends when the staff is younger and can be intimidated. It doesn't matter if games run late due to the new USA Hockey rules. Sherwood runs on time, whether it's a game, a session, whatever. Refs, coaches and those people running the clock are not in charge of when the time is up. PJH needs to as an organization, respect the supervisors in charge at the rink. If Bob gets another call from one of his female employees crying that one of our teams did not get off the ice and is now causing everything to run late, we may no longer be allowed to use Sherwood Ice Arena.

On November 5<sup>th</sup> the 10:30-11:30 Pee Wee teams of Coach McMahon and Coach Turnquist were in the building. Around 12 o'clock an employee saw kids playing in the hall. Later she noticed that all the stickers were picked off the signs and lying on the ground.

Greg Cheetham will contact McMahon and Turnquist to let them know their teams are responsible for \$40 each for a total of \$80.

Don McInnis asked Bob if teams can request to have all lights on for practices as well and Bob said yes.

**REFUND REQUEST:** Steve Peloquin is requesting a refund of all registration fees due to the fact his daughter Marissa cannot play contact hockey for the rest of the season. Letter is on file.

Patti Bergen made a motion to not refund the \$375 but to allow the \$300 rep reserves to be refunded at Bev's discretion, Don seconded. Brett abstained. The vote passed.

**ICE SCHEDULE:** Cheryl Singleton expressed that it is the responsibility of the Board to handle and rein in disrespectful coaches. Don McInnis has already sent out email on Coaches conduct. Anything that happens from this point forward, will be disciplined. U16 team is not on the same page when it comes to the ice schedule. Cheryl has taken to sending emails to all 3 coaches/managers to avoid confusion. High School Hockey has taken the MC ice on Tuesdays. Valley and Mt. View have Okayed no house ice for Presidents Day Weekend. Sherwood has not confirmed as of December 12<sup>th</sup>, 2006.

**FINANCIAL REVIEW:** Bev Puncochar was unable to make the meeting, but gave the financial to Jodi to hand out. Jodi went over briefly with the members. Report is on file.

**OPENS:** Registration Pro-rating: Don made a motion that we don't pro rate any registrations. Second was made. Motion approved. Cut off date is Dec. 31 for new registrations.

Mini-mite's bring a friend (one goal program). It was decided that mites can do what they want with the ice that they already have, to grow hockey and introduce new kids to the sport.

Coachs' evaluations: Email went out to coaches and managers to send out to the parents. It is the managers job to get them turned back in by December 22<sup>nd</sup>. They are to be turned in to the President/Vice-President/Coaching Directors box.

Bags: Randy/Patti needs to follow up with NSA. December 31 is the deadline for PJH to order any bags or warm ups for this year.

Don made a motion to provide Coach Gilbert's Bantam House team the black jerseys due to Mt. View teams also having white jerseys. Motion was seconded. Motion passed unanimously.

Don made a motion to not support the Rick Heinz Goalie School in the future. Motion was seconded. Motion passed. The school failed to pay us our kickback as promised.

Don made a motion that *Greg Galeski* be appointed as Coaching Director and Justin Rock as Director at Large. Motion passed unanimously.
